General:

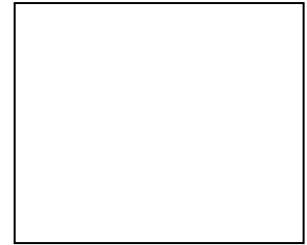
